

Dear Parents

Research Primary School is looking forward to another great year of teaching and learning, and we would like to advise you of our parent contribution arrangements for 2024.

The School is funded predominantly by the State Government and these funds pay staff and contribute to running costs such as electricity, water, some minor building maintenance and many of the other things that are required to operate a government school.

Government funding does not cover the consumables used by students such as books, pens, pencils, computer supplies, art and general supplies, nor does it cover the cost of excursions and general enhancements to buildings and facilities such as new play equipment and school ground developments.

Schools provide students with free instruction to fulfil the standard Victorian curriculum and we want to assure you that all contributions are voluntary. Nevertheless, the ongoing support of our families ensures that our school can offer the best possible education and support for our students. We want to thank you for your support, whether that's through fundraising, volunteering your time or both. This has made a huge difference to our school and the programs we can offer.

Your support along with locally raised money such as our PFC fundraising efforts and money received through curriculum contributions, other contributions, extra-curricular items & activities (listed on the one-page overview attached) are all used to help meet these extra costs and to purchase new equipment.

Within our school, support through 'curriculum contributions' has allowed us to supply students with; quality student supplies (individual stationery bags) and ensures that all students in the class have the same items. Class requisites are also covered such as cover paper, general paper & stock, computer consumables, laminating materials, binders, paint, and class sets of textbooks etc. The contribution also helps with library books & materials, art supplies, literacy & maths supplies, science & general equipment.

The second category of 'other contributions' is used to help pay for maintenance & improvement of facilities such as: painting, safety inspections & grounds; upkeep, play equipment & outdoor areas, along with classroom & school equipment for the children; digital learning, computer devices & first aid / hygiene resources etc.

On Monday 29 January 2024, individual stationery bags will be available at school. We would greatly appreciate a voluntary payment towards your child(ren's) individual stationery bag of \$105, along with a voluntary payment of \$140 towards classroom consumables, materials and equipment used at school.

Please find the payment breakdown/contribution form attached. We would appreciate if you could please complete this form and return to the school by 25 January 2024 so the school can prepare accordingly.

School Council also has an Australian Tax Office endorsed **Tax Deductible Building Fund** which will be maintained at a suggested contribution of \$50. This contribution will also help towards maintaining & improving our buildings and a receipt will be issued to you once paid.

Contribution Method:

Our **preferred way of receiving contributions** for curriculum and other contributions is via COMPASS, you can access this via your child's Compass page under 'course confirmation and payments' (hover over the grid icon). Alternatively, please use the payment breakdown/contribution form attached to this letter.

Refunds:

Parent requests for refunds are subject to the discretion of the school and made on a case-by-case basis. Refunds will be provided where the school deems it is reasonable and fair to do so, taking into consideration whether a cost has been incurred, the Department's Parent Payment Policy and Guidance, Financial Help for Families Policy and any other relevant information.



ONE PAGE OVERVIEW



FREE INSTRUCTION

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the standard curriculum requirements in Victorian Curriculum F-10, VCE and VCAL.
- Schools may invite parents to make a financial contribution to support the school.



PARENT PAYMENT REQUESTS

Schools can request contributions from parents under three categories:

Curriculum Contributions

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

Other Contributions

Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.

Extra-Curricular Items and Activities

Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

- Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).



FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



SCHOOL PROCESSES

- Schools must obtain school council approval for their parent payment arrangements and publish all requests and communications for each year level on their school website for transparency.
